TEN DAY FREE LOOK

If You are not satisfied for any reason, You may return Your Plan Document to the plan administrator within 10 days of the purchase date. Your plan payment will be refunded, provided You have not already departed on the Trip or filed a claim. When so returned, the coverage under the Plan is void from the beginning. (not available to residents of NY or WA)

Benefit Highlights

TRIP CANCELLATION/TRIP INTERRUPTION - Protects the prepaid cost of your covered travel arrangements for your trip in the event you have to cancel or interrupt due to a covered reason.

MISSED CONNECTION - Provides a reimbursement for the unused portions of your travel arrangements, plus the additional costs to join your trip, if your arrival at the trip destination is delayed for 3 hours or more for a covered reason.

TRIP DELAY - Assists with additional travel expenses incurred when you are delayed at least 6 or more hours due to a covered reason. In the event of a covered delay, you will be reimbursed for additional expenses for hotels, meals, and transportation.

BAGGAGE & PERSONAL EFFECTS - Provides reimbursement when your baggage or personal belongings are damaged, lost or stolen during your trip. Personal belongings include such things as loss of luggage, jewelry, passports or travel visas.

GOLF BENEFITS:

Lost Golf Rounds - (not available to residents of MO, NY, OR, WA) Provides reimbursement if you are unable to golf during the trip due to the inability to complete play on at least nine (9) holes of an eighteen (18) hole round due to weather when club management expressly cancels or delays your round.

Golf Obligation - (not available to residents of MO, NY, OR, WA) Provides reimbursement for beverage expenses purchased from the clubhouse, if during your trip, you or a traveling companion makes a hole-in-one on an official registered Golf Course.

SPORTS EQUIPMENT RENTAL - (not available to residents NY & WA) Provides reimbursement for the reasonable cost of renting sports equipment during the trip if it is lost, stolen, damaged or delayed for twelve (12) hours or more.

PROPERTY DAMAGE - (not available to residents of NY) Provides reimbursement for direct physical damage to covered real or personal property within the unit you or a traveling companion occupy while on your trip.

MEDICAL EXPENSE/EMERGENCY EVACUATION - Provides medical expense benefits for a covered sickness or injury incurred while on your trip. When required, we will evacuate you to the nearest qualified hospital and will then return you home when you are safe to travel. Includes up to \$750 for emergency dental expenses.

TRIP CANCELLATION FOR ANY REASON (SECURE PLUS PLAN ONLY PLAN # NW0134-02) - (not available to residents of NY & WA) Provides reimbursement for the percentage of the prepaid, forfeited, non-refundable payments or deposits you paid for your trip provided: a) Your premium payment is received within twenty-one (21) days of the date your initial deposit/payment for your trip is received; and b) You insure all prepaid trip costs that are subject to cancellation penalties or restrictions; and c) You cancel your trip two (2) days or more before your scheduled departure date.

Limitations & Exclusions

This Plan does not cover Loss caused by or resulting from:

1. Pre-Existing Conditions, as defined in the Definitions section;
2. suicide, attempted suicide or any intentionally self-inflicted injury while sane or insane, unless the loss results in the death of a non-traveling Family Member;
3. intentionally self-inflicted injuries;
4. war, invasion, acts of foreign enemies, hostilities between nations (whether declared or not), civil war. This exclusion does not apply if You are an innocent bystander to these events;
5. participation in any military maneuver or training exercise, or any Loss starting while You are in the service of the armed forces of any country. Orders to active military service for training purposes of two months or less will not constitute service in the armed forces. Upon notice to the Company of entering the armed forces, the Company will return to You pro-rata any premium paid, less any benefits paid, for any period during which You are in such service;
6. piloting or learning to pilot or acting as a member of the crew of any aircraft;
7. mental or emotional disorders, unless Hospitalized;
8. participation as an athlete in professional sports;
9. being under the influence of drugs or intoxicants, unless prescribed and used in accordance with the instructions provided by a Physician, unless results in the death of a non-traveling Family Member;
10. intentional commission of or the attempt to commit any dishonest or fraudulent act, or criminal activity (as defined in the jurisdiction where the loss occurred);
11. participation in Bodily Contact Sports, Extreme Sports, Interscholastic Sports or Intramural Sports;
12. dental treatment except as a result of an injury to Sound Natural Teeth except as explicitly offered under Emergency Accident and Sickness Medical Expense; AK, MO, PA
13. any non-emergency treatment or surgery, routine physical examinations, hearing aids, eye glasses or contact lenses;
14. pregnancy and childbirth (except for Complications of Pregnancy) except if Hospitalized;
15. curtailment or delayed return for other than covered reasons;
16. traveling for the purpose of securing medical treatment;
17. services not shown as covered;
18. directly or indirectly, the actual, alleged or threatened discharge, dispersal, seepage, migration, escape, release or exposure to any hazardous biological, chemical, nuclear radioactive material, gas, matter or contamination;
19. confinement or treatment in a government Hospital; however, the United States government may recover or collect benefits under certain conditions;
20. services and/or supplies that do not meet the definition of Necessary Treatment;
21. care or treatment for which compensation is payable under Worker's Compensation Law, any Occupational Disease law; the 4800 Time Benefit plan or similar legislation;
22. care or treatment that is payable under any Other Insurance policy;
23. Accidental Injury or Sickness when traveling against the advice of a Physician;
24. cosmetic surgery or reconstructive surgery;
25. canyoning or canyoneering (traveling in canyons using a variety of techniques that may include walking, scrambling, climbing, jumping, abseiling and/or swimming);
26. a Loss that results from an illness, disease, or other condition, event or circumstance that occurs at a time when Your coverage is not in effect.
